

BCCC Reading and Writing Placement Tests

Welcome to the Bucks County Community College Reading and Writing placement tests. Please follow the directions below. They will walk you through how to create your account in College Success, load the tests into your dashboard, and complete them. Please note, College Success is a separate website from Bucks or ALEKS. You will be creating a new account for this. **Your login information for MyBucks or ALEKS will not work on College Success.**

The Reading placement test is a one-hour timed test that will be used to determine if you need to take a Reading class. You will answer 40 multiple-choice questions on reading passages. At the end of the reading portion, you will transition into the Writing portion. Once you go forward to the next question, you cannot go back to a previous question.

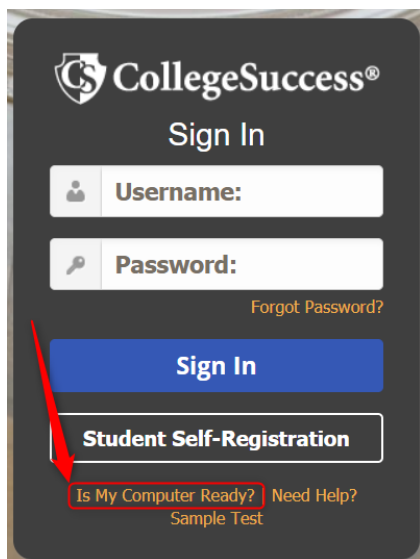
The Writing placement test is a 50-minute timed test that will be used to determine your Writing class. You will be asked to respond to **one** essay prompt. Recommended responses are 300-500 words. There is no spell check or grammar check.

IMPORTANT: If you only have access to a tablet or mobile device, the test will not work on your device. You must test in person in the Testing Center. Visit <https://www.bucks.edu/academics/testing/placement/schedule/> for the testing schedule.

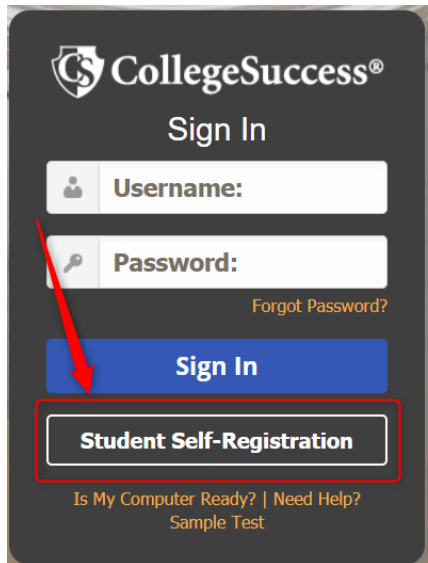
Remember: **Your Writing Placement test should be an accurate reflection of your own writing.** If plagiarism or outside aid is suspected, your scores will be voided and retesting in person will be required.

Creating Your Account

1. Go to college.measuredsuccess.com
2. Make sure pop-ups are enabled. Click Is My Computer Ready? to verify your browser meets the requirements.

3. Click Student Self-Registration at the bottom of the page



4. On the Student Self-Registration page, under Institution, select BCCC (Pilot)



5. Under Site, select Bucks



6. Under Site Password, enter **VAN126923** (Note: Site Password is case-sensitive.)
